### **BREAKING NEWS: Monday February 10, 2025, Court Continues Temporary Stay of Resignation Deadline**

**Dear AFGE National Council 222 Members,**

I am pleased to share that in our ongoing fight for fairness and transparency, during today's hearing, the court continues the temporary stay on the resignation deadline originally set for February 6, 2025, and then moved to Monday February 10th. This means the resignation deadline for today Monday February 10th has been formally suspended, we are tracking for how long this stay will be, giving us the time and opportunity to address the critical issues surrounding the "Fork in the Road" proposal.

This outcome is a testament to the strength of our legal arguments and the collective resolve of our members. It is a step forward in ensuring that your rights and interests are fully protected.

#### **What This Means for You:**

- The resignation deadline is officially stayed until further notice.
- No immediate action is required from employees regarding resignation decisions.
- All current work arrangements remain in place during this period.

#### **Why This Matters:**

The "Fork in the Road" proposal raised serious concerns about its lack of guaranteed funding, absence of binding contractual protections, and insufficient safeguards for long-term benefits. By securing this stay, we have ensured that these critical issues will be addressed through proper legal channels before any irreversible decisions are made.
